SINCE 1984, MORE THAN 59,600 FAMILIES WORLDWIDE HAVE CALLED THIS RONALD MCDONALD HOUSE "HOME". LAST YEAR, WE SERVED 2,700 FAMILIES. WHILE OVER 65% OF OUR FAMILIES COME FROM WISCONSIN, MANY HAVE TRAVELED ACROSS THE UNITED STATES TO SEEK LIFE-GIVING MEDICAL CARE AT CHILDREN'S WISCONSIN, ROGERS BEHAVIORAL HEALTH, AND OTHER AREA HOSPITALS. WE SERVE UP TO 84 FAMILIES DAILY AND COULD SERVE NEARLY EVERY FAMILY NEEDING OUR HOUSE DURING 2024. ON AVERAGE, OUR FAMILIES STAY WITH US FOR JUST OVER 8.2 DAYS; HOWEVER, OVER 55% OF FAMILIES STAY FOR LONGER THAN 30 DAYS.
